

**WOOD COUNTY SHERIFF'S FEE SCHEDULE**

Ohio Revised Code, Sec. 311.17

(A) For the services and return of the following writs and orders:

- (1) Execution:
  - [a] When money is paid without levy or when no property is found..... \$30.00
  - [b] When levy is made on real property, for the first tract..... \$25.00 Each additional \$10.00
  - [c] When levy is made on good and chattels, including inventory..... \$50.00
- (2) Writ of attachment of property, except for the purpose of garnishment..... \$40.00
- (3) Writ of attachment for the purpose of garnishment..... \$10.00
- (4) Writ of replevin..... \$40.00
- (5) Warrant to arrest, for each person named in the writ..... \$20.00
- (6) Attachment for contempt, for each person named in the writ..... \$6.00
- (7) Writ of possession or restitution..... \$60.00
- (8) Subpeona, for each person named in the writ. Civil or Criminal..... \$10.00
- (9) Venire, for each person named in the writ. Civil or Criminal..... \$6.00
- (10) Summoning each juror, other than venire. Civil or Criminal..... \$6.00
- (11) Writ of partition..... \$25.00
- (12) Order of sale of on partition for the first tract..... \$50.00 Each additional \$25.00
- (13) Other order of sale of real property for the first tract..... \$50.00 Each Additional \$25.00
- (14) Administering oath to appraisers (each)..... \$3.00
- (15) Furnishing copies for advertisements, for each hundred words..... \$1.00
- (16) Copy of indictment, for each defendant..... \$5.00
- (17) All Summons, writs, orders or notices for the first name..... \$6.00 Each Additional \$1.00

(B) In addition to the fee for service and return:

- (1) On each summons, writ, order, or notice, a fee of two dollars per mile for the first mile, and one dollar per mile for each additional mile, going and returning, actual mileage to be charged on additional names.
- (2) Taking bail bond..... \$3.00
- (3) Jail fees, as follows:
  - [a] For receiving a prisoner..... \$5.00
  - Each time a prisoner is received; discharged or surrendered \*\*..... \$5.00
  - [b] Taking a prisoner before a judge of court, per day..... \$5.00
  - [c] Calling action..... \$1.00
  - [d] Calling jury..... \$1.00
  - [e] Calling each witness..... \$3.00
  - [f] Bring prisoner before court on habeas corpus..... \$6.00
- (4) Poundage on all moneys actually made and paid to the Sheriff on execution, decree, or sale of real estate, one and one-half per cent.
- (5) Making and executing a deed of land sold on execution, decree, or order of the court, to be paid by the purchaser..... \$50.00

\*\* Does not apply to departures or returns to a program established under ORC 5147.28.
